# **General information**

The purpose of Form 40-EXT, Corporation Extension Payment Voucher, is to provide a corporation that is unable to file its Form 40, Corporation Income Tax Return, by the due date, the means of remitting its tax payment on or before the original due date of the return.

A corporation must prepay its entire state tax liability by the regular due date of the tax return for the taxable year, or interest at the rate of 12% per annum will apply to any payment made after the regular due date of the state tax return.

The extension payment may be made by check, money order, or electronically.

Regardless of which method of payment is chosen, it must be made no later than the original due date of the return.

A corporation filing on a fiscal year basis or on a short period return must enter the tax year beginning and ending dates on the Form 40-EXT voucher, otherwise leave blank.

# To pay electronically

If you choose to pay electronically, do not use the voucher below.

### Do Not Use This Voucher If:

- The extension payment is made using any type of electronic payment
- The return is filed on or before the original due date of the return
- The balance due is going to be paid after the original due date of the return
- The corporation files Form 60, Small Business Corporation Income Tax Return
