Purpose

A partnership may, but is not required to, make estimated tax payments of income tax expected to be due on Form 58. This form is for the 2026 tax year.

How to make payment

If paying by check or money order, make it payable to "ND State Tax Commissioner" and write last four digits of federal employer identification number (FEIN) and "2026 58-ES" on it. Complete the payment voucher below, detach it from this page, and mail it with the check or money order to:

Only a check drawn on a U.S. or Canadian bank in U.S. dollars and using a standard 9-digit routing number is accepted.
