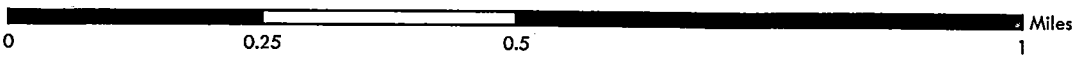
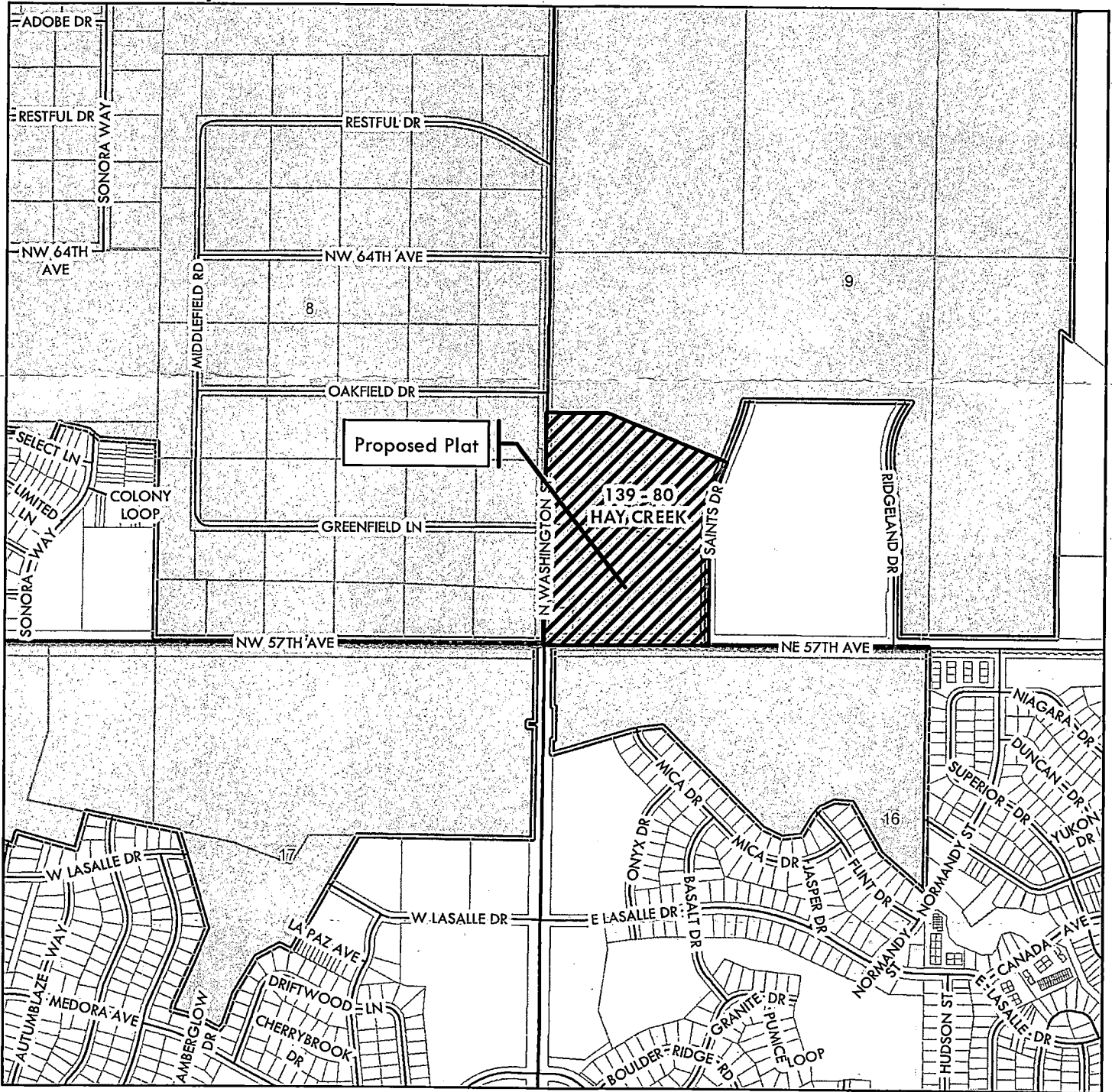

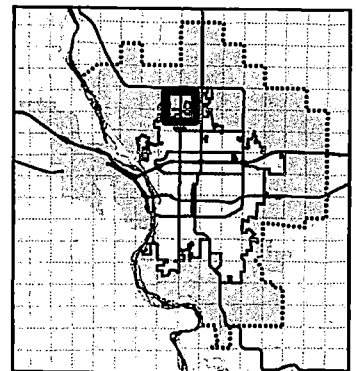
**Proposed Major Plat, Annexation, Future Land Use Plan Amendment and Zoning Change (A to Conditional RT and Conditional CA)
