ORDINANCE NO. 1045

AN ORDINANCE relating to the annexation of a tract of land located southeast of I-94 and Exit 292, described as Parcel 1B-1 and Parcel 1B-2 in Section 28, Township 140N, Range 58W, County of Barnes, State of North Dakota.

WHEREAS, a duly signed petition has been presented to the Board of City Commissioners of the City of Valley City, Barnes County, North Dakota, pursuant to Section 40-51.2-03 of the North Dakota Century Code, as amended; and

WHEREAS, notice of the filing of said petition has been duly given by publication, as provided for by Section 40-51.2-05 of the North Dakota Century Code, as amended, by publishing notice thereof in the Valley City Times-Record as required by law; and

WHEREAS, notice of the time and place of consideration of the petition was mailed, by certified mail, to the Barnes County Auditor and the Clerk of Valley Township;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF VALLEY CITY, BARNES COUNTY, NORTH DAKOTA:

Section 1. That the boundaries of the City of Valley City, Barnes County, North Dakota, be and they are hereby extended so as to include and to incorporate within the corporate limits of the City of Valley City, Barnes County, North Dakota, the following tract(s) of land:

Parcel Number 1B-1

A portion of the SE¼ of Section 28, Township 140N, Range 58W of the 5th Principal Meridian, County of Barnes, State of North Dakota;

and

Parcel Number 1B-2

A portion of Parcel No. 2, less the northwesterly 75' of the E½ of the SW¼ of Section 28, Township 140N, Range 58W of the 5th Principal Meridian, County of Barnes, State of North Dakota.

Section 2. That the President of the Board of City Commissioners of the City of Valley City, North Dakota, shall file and record a certified copy of this ordinance together with an accurate map of the annexed area with the County Recorder in and for Barnes County, North Dakota.

Section 3. This ordinance shall take effect and be in full force from and after its passage and approval by the President of the Board of City Commissioners and after a certified copy of the same together with a map of said area annexed is recorded in the office of the County Recorder in and for Barnes County, North Dakota.



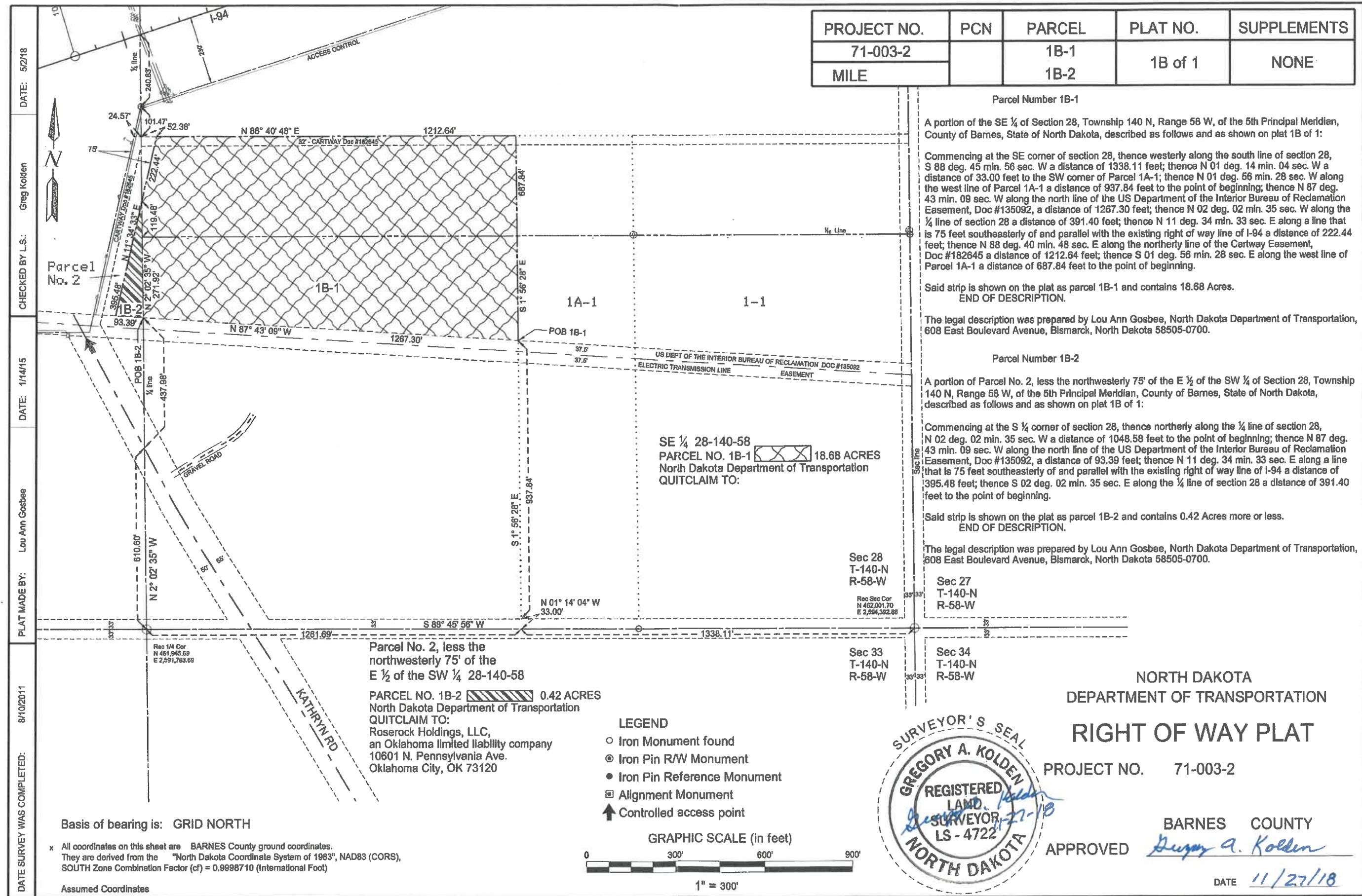

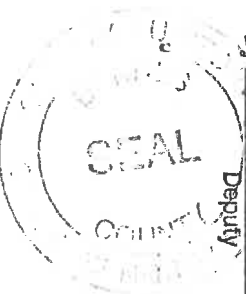
