

# AN ORDINANCE TO ANNEX LANDS PLATTED AS KORYNTA SECOND ADDITION AS FOLLOWS:

TO ANNEX ALL OF LOT 1, BLOCK 1, KORYNTA SECOND ADDITION, BEING PART OF THE NORTH HALF OF SECTION 32, TOWNSHIP 152 NORTH, RANGE 50 WEST OF THE FIFTH PRINCIPAL MERIDIAN, GRAND FORKS COUNTY, NORTH DAKOTA, CONTAINING 217,800 SQUARE FEET OR 5.0 ACRES.
