AN ORDINANCE TO **ANNEX LANDS PLATTED AS MAIER'S FIFTH ADDITION** TO THE CITY OF GRAND FORKS, NORTH DAKOTA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND FORKS, NORTH DAKOTA, THAT:

Section 1.

Phase I

The following territory is hereby annexed to the City of Grand Forks, North Dakota, together with the full width of all platted streets and public rights-of-way contiguous thereto:

LOTS 1. 2 AND 3. BLOCK 1. MAIER'S FIFTH ADDITION TO THE CITY OF GRAND FORKS, NORTH DAKOTA.

SAID TRACTS CONTAIN 406,972 SQUARE FEET OR 9.35 ACRES, MORE OR LESS, AND IS AS SHOWN ON THE ATTACHED MAP, WHICH IS BY REFERENCE MADE A PART HEREOF.

Phase II

The following territory is hereby annexed to the City of Grand Forks, North Dakota, together with the full width of all platted streets and public rights-of-way contiguous thereto:

LOT 4. BLOCK 1. MAIER'S FIFTH ADDITION TO THE CITY OF GRAND FORKS, NORTH DAKOTA.
