AN ORDINANCE ANNEXING PROPERTY TO THE CORPORATE LIMITS OF THE CITY OF BISMARCK, NORTH DAKOTA, DECLARING THE TERRITORY ANNEXED; DECLARING THE SAME TO BE A PART OF THE CORPORATE LIMITS OF SAID CITY.

BE IT ORDAINED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF BISMARCK, NORTH DAKOTA.

Section 1. <u>Territory Annexed</u>. The territory and land hereinafter described is hereby declared and found to be a part of the corporate limits of the City of Bismarck, Burleigh Caunty North Dakota, as follows:

> Lots 24-33, Block 1; Lots 1-4 and 15-44, Block 2; Lots 1-2 and 9-12, Block 3; Lot 1, Block 4; Lots 1-3, Block 5; Lots 1-21, Block 6, and all adjacent rightof-way, all within Silver Ranch First Addition First Replat, and the North half of the adjacent 43rd Avenue NE right-of-way, more precisely described as the East 471.61 feet of the West 2,194.70 feet of the South 75 feet of the SW ¼ of Section 18, T139N-R79W/Gibbs Township, included in Document# 845385.

The above described tract of land contains 19.34 acres, more or less.

Section 2. <u>Provisions Applicable</u>. From and after the final passage and adoption of this Ordinance and upon recording of this ordinance with the Burleigh County Recorder, the territory herein described shall be a part of the corporate limits of the City of Bismarck, North Dakota.




Location Map Parts of Blocks 1-6, Silver Ranch First Addition First Replat
