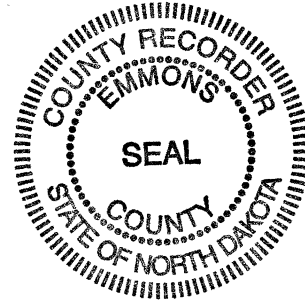

**RESOLUTION APPROVING THE ANNEXATION OF A TRACT OF LAND 150' by  
150' WITHIN THE SW1/4 OF SECTION 8, T132N, R76W, LINTON, ND OR AS

WHEREAS, the City of Linton, Emmons County, North Dakota, is a municipal corporation, organized and existing under the laws of the State of North Dakota; and

WHEREAS, there is contiguous and adjacent to the City of Linton a tract or parcel of land hereinafter specifically described, containing approximately 0.52 acres, more or less, which tract or parcel of land is not presently a part of the City of Linton.

BE IT RESOLVED by the governing body of the City of Linton, North Dakota, that the boundaries of the City of Linton be, and they are hereby extended as to include and incorporate within the corporate limits of the City of Linton, Emmons County, North Dakota, the following described land, to-wit:

BE IT FURTHER RESOLVED, by the governing body of the City of Linton, North Dakota, that this Resolution be published in the official newspaper for the City of Linton once each week for two successive weeks, that notice of the Resolution be mailed to the owner of each parcel of real property within the area to be annexed at the person's last known mailing address, and a hearing be held on Monday, August 5<sup>th</sup>, 2019, at 5:00 p.m. in the City Hall, Linton, North Dakota. The owners of any real property within the territory proposed to be annexed, within 30 days of the first publication of such resolution may file written protests with the City Auditor protesting against the proposed annexation.

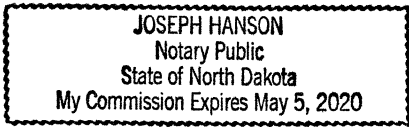


