

CITY OF DEVILS LAKE

SALES, USE & GROSS RECEIPTS TAX

At the present time, the City of Devils Lake has a 2.25% sales, use, and gross receipts tax. Effective January 1, 2023, the City of Devils Lake has adopted an ordinance to increase its city sales, use, and gross receipts tax by 0.25%. The tax rate for Devils Lake starting January 1, 2023, will be 2.5%. The following applies:

- New farm machinery and farm irrigation equipment is exempt from local tax
- Maximum tax (refund cap) increases to \$35.00 per sale
- Permit holder compensation of 3% of the tax due, maximum \$83.33 per month or \$250.00 per quarter
- Limited exemption for contractors applies
- Tax imposed applies to contract bids submitted on or after effective date

The North Dakota Office of State Tax Commissioner has contracted with the City of Devils Lake to administer the city sales, use, and gross receipts tax. Tax is computed by multiplying the taxable purchase amount by the tax rate and carrying the product to the third decimal place. If the third decimal place is five or greater, round up; if it is four or less, round down. A local tax guideline is available at www.tax.nd.gov/guidelines.

Effective January 1, 2023, the combined state and city rates within the city limits of Devils Lake will be as follows:

- General sales and use tax: 7.5% (5% state + 2.5% city)
- New farm machinery and farm irrigation equipment: 3% (3% state)
- New manufactured homes: 5.5% (3% state + 2.5% city)
- Lodging:
 - O Hotel, motel, and tourist court accommodations and bed & breakfast accommodations licensed under North Dakota Century Code Ch. 13-09.1:
 - 10.5% (5% state + 2.5% city + 2% lodging tax + 1% local lodging and restaurant tax)
- Restaurants, concession stands, and mobile food trucks (sale of food and non-alcoholic beverages):
 - \circ 8.5% (5% state + 2.5% city + 1% local lodging and restaurant tax)
- Alcoholic beverages:
 - Off-sale alcoholic beverages: 9.5% (7% state + 2.5% city)
 - On-sale alcoholic beverages: 9.5% (7% state + 2.5% city)
