Use this worksheet to calculate the adjustment amount to enter on Form ND-1, line 4, if you itemized your deductions for federal income tax purposes on Schedule A (Form 1040)\* and either of the following apply:

- You are claiming a credit on both Schedule ND-1PG, line 7, and Schedule ND-1QEC, line 5.
- You are claiming an endowment fund credit from an estate, trust, partnership, or S corporation (North Dakota Schedule K-1).

**Exceptions to use of worksheet.** Do not complete this worksheet and do not enter any amount on Form ND-1, line 4, if you claimed the standard deduction on your 2022 Form 1040, line 12, and you are not claiming a credit on Schedule ND-1QEC, line 5, that is based on a contribution made from an individual retirement account (IRA) under I.R.C. § 408(d).

**Attach worksheet to Form ND-1**

**\*Note: A reference to Form 1040 includes Form 1040-SR.**

- If you are claiming a credit on Schedule ND-1PG, enter the amount from line 4 of that schedule. If not claiming a credit on Schedule ND-1PG, or if the amount on Schedule ND-1PG, line 4, is zero, enter -0- on line 1d, and go to line 2 ..... **1a** \_\_\_\_\_
  - Enter the portion of the amount on line 1a that you claimed as a deduction on Schedule A (Form 1040). If zero, enter -0- on line 1d and go to line 2 ..... **1b** \_\_\_\_\_
  - Enter amount from Schedule ND-1PG, line 6..... **1c** \_\_\_\_\_
  - Enter smaller of line 1b or line 1c..... **1d** \_\_\_\_\_
- If you are claiming an endowment fund credit from an estate, trust, partnership, or S corporation, enter the total of the contribution amounts from ND Schedule K-1 (Form 38), lines 14b and 14d, ND Schedule K-1 (Form 58), lines 14b and 14d, and ND Schedule K-1 (Form 60), lines 11b and 11d. Otherwise, enter -0- on line 2b and go to line 3. .... **2a** \_\_\_\_\_
  - Enter the portion of the amount on line 2a that you claimed as a deduction on Schedule A (Form 1040). If zero, enter -0- on this line and go to line 3..... **2b** \_\_\_\_\_
- Add line 1d and line 2b ..... **3** \_\_\_\_\_
- If you claimed itemized deductions from Schedule A on your Form 1040, line 12, enter the amount from Schedule A (Form 1040), line 17. Otherwise, enter -0- on line 5 and go to line 6..... **4a** \_\_\_\_\_
  - Enter the standard deduction you would have been allowed on your Form 1040, line 12, had you not itemized deductions on Schedule A (Form 1040)..... **4b** \_\_\_\_\_
  - Subtract line 4b from line 4a..... **4c** \_\_\_\_\_
- Enter the smaller of line 3 or line 4c ..... **5** \_\_\_\_\_
- If you are claiming a credit on Schedule ND-1QEC, enter the amount from Schedule ND-1QEC, line 2. If not claiming a credit on Schedule ND-1QEC, or if the amount on Schedule ND-1QEC, line 2, is zero, skip lines 6a through 9, and enter the amount from line 5 on line 10 ..... **6a** \_\_\_\_\_
  - If line 6a includes a contribution consisting of a nontaxable transfer of monies from an individual retirement account (IRA) under I.R.C. § 408(d), enter the amount transferred from the IRA to the endowment fund. Otherwise, enter -0- on this line ..... **6b** \_\_\_\_\_
  - Non-IRA contribution(s). Subtract line 6b from line 6a ..... **6c** \_\_\_\_\_
  - Enter the portion of the amount on line 6c (non-IRA contributions on Schedule ND-1QEC) that you claimed as a deduction on Schedule A (Form 1040) ..... **6d** \_\_\_\_\_
  - Subtract line 5 from line 4c ..... **6e** \_\_\_\_\_
- Enter the smaller of line 6d or line 6e..... **7** \_\_\_\_\_
- If line 6b is zero, enter -0- on line 9 and go to line 10. Otherwise, enter amount from Schedule ND-1QEC, line 4 ..... **8a** \_\_\_\_\_
  - Enter the amount from line 7..... **8b** \_\_\_\_\_
  - Subtract line 8b from line 8a..... **8c** \_\_\_\_\_
- Enter the smaller of line 6b or line 8c..... **9** \_\_\_\_\_
- Adjustment amount. Add line 5, line 7 and line 9. Enter this amount on Form ND-1, line 4, and attach this worksheet to your return ..... **10** \_\_\_\_\_
