



**Purpose**

A partnership may, but is not required to, make estimated tax payments of income tax expected to be due on Form 58. This form is for the 2025 tax year.

**How to make payment**

If paying by check or money order, make it payable to "ND State Tax Commissioner" and write last four digits of federal employer identification number (FEIN) and "2025 58-ES" on it. Complete the payment voucher below, detach it from this page, and mail it with the check or money order to:

Only a check drawn on a U.S. or Canadian bank in U.S. dollars and using a standard 9-digit routing number is accepted.
