Form 60-PV **2025**

What is Form 60-PV?

Use this form if submitting a paper check or money order to pay a tax balance due on a 2025 Form 60. Do not use this form if paying electronically - see "How to make payment" for payment options.

Do not use Form 60-PV to make an extension payment. Extension payments should be made using the extension payment voucher, Form 60-EXT.

When is the payment due?

The payment must be made on or before the 15th day of the 4th month following the end of the tax year to avoid any late payment penalty or interest.

How to make payment

Make check or money order payable to "ND State Tax Commissioner" and write last four digits of federal employer identification number (FEIN) and "2025 Form 60-PV" on it. Complete the payment voucher, detach it from this page, and enclose it with payment and return. If Form 60 has already been filed, mail payment and voucher to:

Only a check drawn on a U.S. or Canadian bank in U.S. dollars and using a standard 9-digit routing number is accepted.

Electronic payment options. Instead of paying by check or money order with this payment voucher, the payment may be made electronically with an electronic check, a debit or credit card, or an Automated Clearing House (ACH) credit transaction.

To pay electronically, or for more information, go to **www.tax.nd.gov** and select "Make A Payment."

If paying electronically, do not use this payment voucher.
