**PLEASE TAKE FURTHER NOTICE** that N.D.C.C. § 57-36-05.2 provides:

A dealer, distributor, or other person may not knowingly sell or distribute in this state any tobacco product manufactured by a tobacco product manufacturer not in compliance with N.D.C.C. § 51-25-02(2).

**PLEASE TAKE FURTHER NOTICE** that knowingly selling or distributing tobacco product manufactured by a tobacco product manufacturer not in compliance with N.D.C.C. § 51-25-02(2) is a violation of N.D.C.C. Ch. 57-36 and may subject the dealer or distributor to the penalties in N.D.C.C. §§ 57-36-04 and 57-36-33.
